# THE GALLERY

*Members of the gallery must remember that they are spectators and should do nothing that would distract dog, handlers, or judges. The following pointers for AKC Hunting Tests and Field Trials may help make everyone's experience a good one.*

- The gallery must not fan out across the field or straggle too far behind.
- It is important to be courteous to the other members of the gallery.
- Go quietly and do not volunteer information unless it has been requested.
- The marshal is in control of the gallery at all times. The gallery may not move in front of the marshal, judges or handlers. Do not move past a handler who is casting off, or after bird work. If the dogs in a brace become separated, only the appointed scout (FT only) may move forward with the handler and judge; unless given permission by the judge to move on, other members of the gallery must remain behind the marshal.
- If a dog or handler is trying to come up through a gallery, move aside and let them through. When a dog is called on point, do not rush up on the dog, but go quietly behind the marshal to a place where the bird work may be observed. Be especially mindful of the directions given by the marshal in stakes where live gun fire is expected. (HT only.)
- AKC regulations prohibit members of the gallery from talking to the judges. Please keep this in mind and do not distract the judges. It only takes a split second to miss an opportunity to evaluate a dog working.

Be sure to practice good sportsmanship and safe practices; participating in the gallery should be fun.

## CAMPING

Camping is allowed beginning Friday, 3 hookups are available (water & Electricity only) at this time reserved on a first come first serve basis through the ISCH @ \$20/night. Please limit generators to use of those that are *park rated* for noise control. Water is available at several locations on the property – near the troughs and at the trailer house fence. Please clean up the grounds before you leave. Smoking is permitted only in the camping area, not on course.

Lunch will be available Saturday & Sunday at a nominal charge.

Water will be available in the camping area and on course.

## REMINDERS

- ◆ The hotels have been assured that these dogs are mannerly and will be crated in the absence of owner. Please remember to clean up after dogs.
- ◆ Always carry proof of current RABIES vaccinations for all dogs and horses. (Tags are not enough.) Negative Coggins required for horses.
- ◆ BLAZE ORANGE clothing must be worn in all live shooting tests, and is encouraged in ALL tests.
- ◆ EXHIBITORS and SPECTATORS should wear clothing suited to the event and the weather - Boots are preferred over tennis shoes; layered clothing can be adjusted to weather changes.

To perform at their best, DOGS should be conditioned and adequately prepared for exposure to typical Texas groundcover, shrubbery and temperatures.

The physical address is 647 CR 316, Caldwell. The number "647" appears on the post at the main gate.

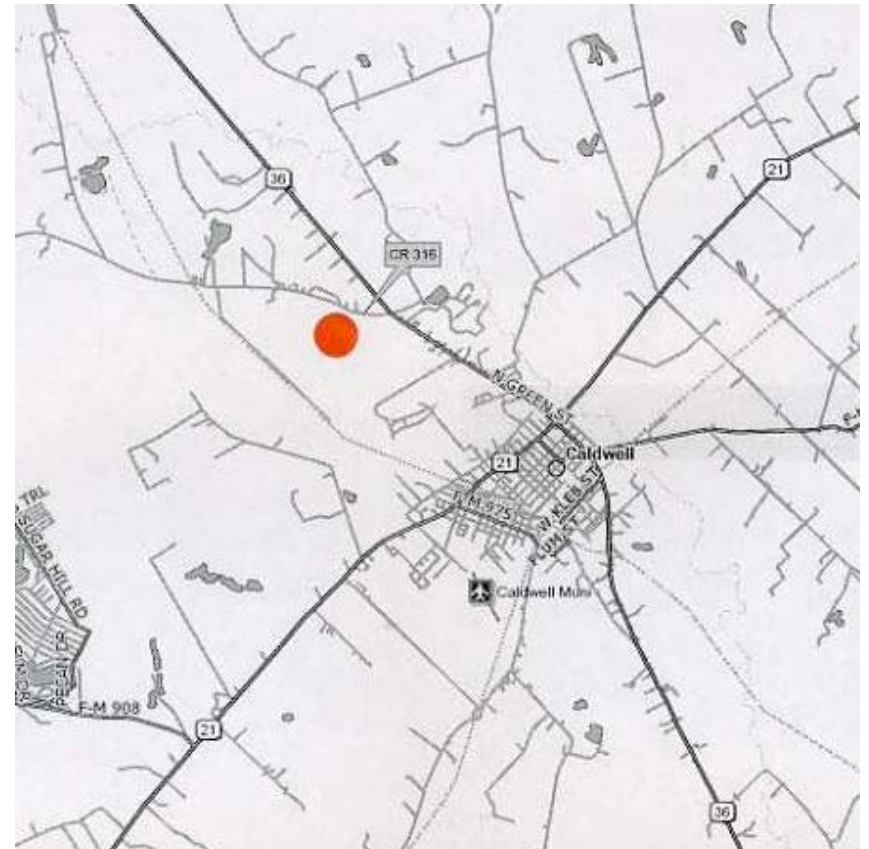
>**From Houston:** Take US 290 until you have gone around Brenham and then stay on TX 36 and go through Somerville and on to Caldwell. Continue to go straight on TX 36 for 1.6 miles after the main intersection in Caldwell (TX 21). Turn left on CR 316 and continue 0.5 miles to the gate to the ranch on the left.

>**From Austin:** Take TX 71 to Bastrop and take TX 21 to Caldwell or take US 290 to (near) Paige and take TX 21 to Caldwell. In Caldwell, turn left on TX 36 and follow the instructions above from Caldwell.

>**From San Antonio:** Take I-35 to San Marcos and then take TX 21 to Caldwell. Follow the instructions above from Caldwell.

>**From Waco (Dallas, Fort Worth):** Take US 77 from Waco and then stay on TX 36 after Cameron. Turn right on CR 316 just before entering Caldwell. Go 0.5 miles to the gate on the left.

**Please reduce speed when nearing the grounds and be aware of any persons and animals crossing the road. Thank you.**
